

Terms & Conditions of the World's Longest Lunch 2026 VIP Promotion (Promotion)

Participation in this promotion is deemed acceptance of these Terms.

About the Promoter

1. La Trobe Financial Services Pty Limited (ABN 30 006 479 527) (**La Trobe Financial**) of Level 25, 333 Collins Street, Melbourne VIC 3000 is the promoter of the Promotion. Melbourne Food & Wine Festival is an event created and organised by Food + Drink Victoria Ltd ABN 28 481 651 315, Level 4, 99 King Street, Melbourne, VIC, 3000 (**F+D Victoria**). F+D Victoria will provide the prize to the Winners on La Trobe Financial's behalf.
2. Information on how to enter, and the prize details, form part of these Terms and Conditions (**Terms**).

Promotional Period

3. Entries into the Promotion open on Monday 23 February 2026 at 9:00am (AEDT) close on Sunday 8 March 2026 at 11:59pm (AEDT) (**Promotional Period**).

Eligible Entrants

4. Eligible Entrants are persons who:
 - a) are Australian citizens, or permanent Australian residents aged 18 years or older, excluding employees and immediate family members¹ of F+D Victoria or La Trobe Financial and its related entities;
 - a) be residents of Victoria, Australia at time of promotion Draw.

Prize

5. The prize will be awarded to three (3) Eligible Entrants randomly drawn (**Winner(s)**). Each Winner will receive the following from F+D Victoria:
 - a) two VIP entry tickets to the Melbourne Food & Wine Festival 2026 World's Longest Lunch, held on Friday 20 March 2026 (12:00pm AEDT) at Kings Domain, Melbourne; and
 - b) an opportunity to meet and greet selected hosts and chefs of the World's Longest Lunch 2026 event (together, the **Prize**).

- The total prize pool for the Promotion is valued at approximately \$3,570 (excluding GST) as at February 2026.

Entry into the Promotion

- Eligible Entrants must complete the entry form located at <https://form.jotform.com/260358558829876> and accept the promotion Terms (**Entry**). Entrants are only eligible to make one (1) Entry to the Promotion; duplicate entries will be omitted from the Draw.

Promotion Draw

- The lottery draw will be conducted electronically by a La Trobe Financial representative at 12:00pm (AEDT) on Monday 9 March 2026, or as soon thereafter as practicable at La Trobe Financial's office on 333 Collins Street, Melbourne VIC 3000 (**Draw**).
- La Trobe Financial will contact the Winners via email and telephone within two business days of the Draw. The Winners will be permitted two business days to accept the Prize (or such longer period as notified by La Trobe Financial) and provide any further information requested by La Trobe Financial. If the Winners accept the Prize, La Trobe Financial will publish the Winners' details (last name, first initial and postcode) on La Trobe Financial's website, within seven days of the Draw.

F+D Victoria and/or La Trobe Financial reserve the right in its sole discretion to the fullest extent permitted by law at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms, or who tampers with the entry process.

Privacy Consent and Liability

17. In order for entrants to participate in the Promotion, La Trobe Financial may collect the name, age, email, address and postcode and telephone number of each entrant (Personal Information). All Personal Information provided by an entrants will be used by La Trobe Financial and on behalf of selected third parties in accordance with its Privacy Policy. This may include for promotional and direct marketing purposes and other disclosures as specified in La Trobe Financial's Privacy Policy (www.latrobefinancial.com.au/privacy-policy), and sending electronic messages directly to entrants.

If the Personal Information requested is not provided, or the entrant does not consent to their Personal Information being used for the above primary purpose, the entrant should not participate in the Promotion. By entering the Promotion, the entrant understands and agrees that La Trobe Financial may disclose the information provided by the entrant to a lottery regulator (if necessary), publish the Winner's name as required under relevant lottery legislation, as well as use their Personal Information for further promotional, marketing and publicity purposes.
